

FIFTH SUNDAY IN LENT

FIRST READING: Jeremiah 31:31-34 (35B)

The days are coming, says the LORD, when I will make a new covenant with the house of Israel and the house of Judah. It will not be like the covenant I made with their fathers the day I took them by the hand to lead them forth from the land of Egypt; for they broke my covenant, and I had to show myself their master, says the LORD. FIFTH SUNDAY IN LENT

GOSPEL: John 12:20-33

Some Greeks who had come to worship at the Passover Feast came to Philip, who was from Bethsaida in Galilee, and asked him, “Sir, we would like to see Jesus.” Philip went and told Andrew; then Andrew and Philip went and told Jesus. Jesus answered them, “The hour has come for the Son of Man to be glorified. Amen, amen, I say to you, unless a grain of wheat falls to the ground and dies, it remains just a grain of wheat; but if it dies, it produces much fruit. Whoever loves his life loses it, and whoever hates his life in this world will preserve it for eternal life. Whoever serves me must follow me, and where I am, there also will my servant be. The Father will honor whoever serves me. “I am troubled now. Yet what should I say? ‘Father, save me from this hour?’ But it was for this purpose that I came to this hour. Father, glorify your name.” Then a voice came from heaven, “I have glorified it and will glorify it again.” The crowd there heard it and said it was thunder; but others said, “An angel has spoken to him.” Jesus answered and said, “This voice did not come for my sake but for yours. Now is the time of judgment on this world; now the ruler of this world will be driven out. And when I am lifted up from the earth, I will draw everyone to myself.” He said this indicating the kind of death he would die.

PROFESSION OF FAITH - NICENE CREED

Weekdays of Lent:

There is no obligation to fast. However, voluntary acts of self-denial are recommended.

Ash Wednesday and Good Friday:

These are days of *Fast and Abstinence from meat*. There is a limit of **one** full meal on these days for all between the ages of 18 and 59 inclusive.

Days of Abstinence: (All Fridays in Lent)

All who have reached their 14th year are bound to abstain totally from meat.

Easter Duty Obligation:

After they have received their First Holy Communion, Catholics are bound by the obligation of receiving Holy Communion at least once a year. This precept should be fulfilled during the Easter Season. Catholics are also bound to confess serious (mortal) sins at least once a year, but this is not limited to the Lenten/Easter Season.



Confirmation Prep (Fall, 2021)

The majority of students/families opted for "in person" instruction, using the book "Decision Point" with Mr. Tom Salerno, Catechist. There are two separate sessions all scheduled in the Parish Hall on (2) two Sundays each month. Session A- meets from 3:00 - 4:30 pm. Session B- meets from 5:00 - 6:30 pm

Fifteen (15) classes are being offered. Students are required to attend ten (10) classes.


