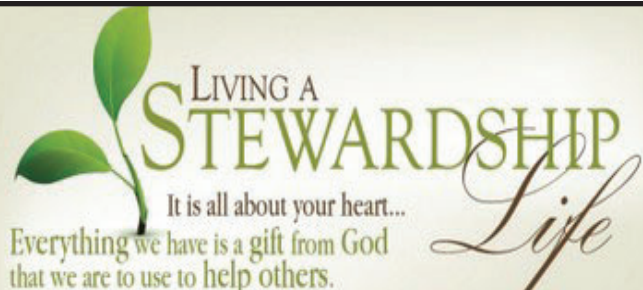

FIFTH SUNDAY OF EASTER

GLORIA

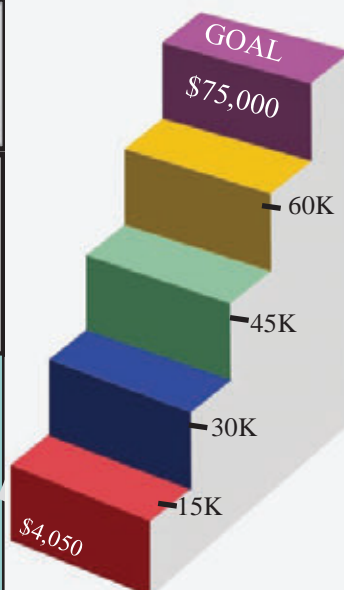

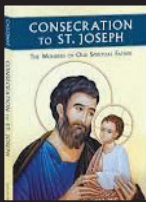

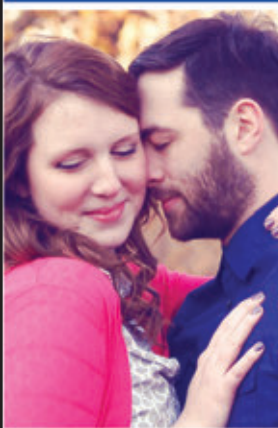
