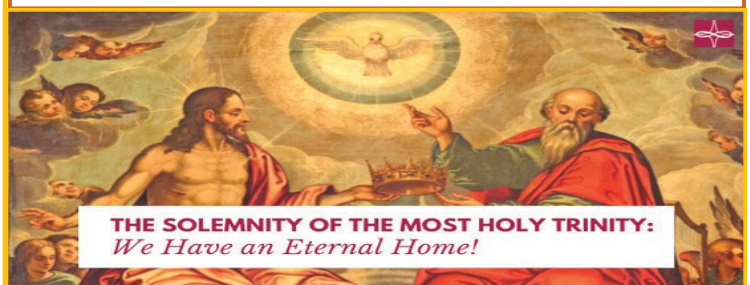

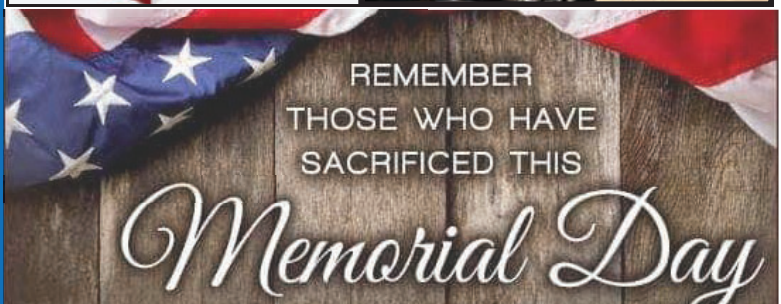
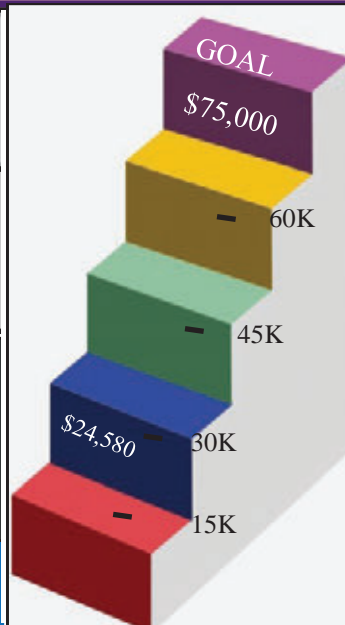

# NEW JERSEY CATHOLIC CONFERENCE

## STATEMENT OF THE NEW JERSEY BISHOPS *Reinstating the General Obligation to Attend Mass*

At this time, due to the observance of public safety protocols and the increase in the availability of vaccines, we have begun a return to some sense of normalcy in various sectors of our society.

Therefore, we the Catholic Bishops of New Jersey, are lifting the dispensation of the Sunday and Holy Days Mass obligation **beginning on Saturday, June 5, 2021, and Sunday, June 6, 2021**, Solemnity of the Most Holy Body and Blood of Christ. We welcome the Christian faithful to return to the regular participation in the Sunday Eucharist, the source and summit of our Catholic faith (cf. Code of Canon Law canon 1247 and Catechism of the Catholic Church, n. 2180).

This obligation does not apply to those who are ill; those who have reason to believe that they were recently exposed to the coronavirus or another serious or contagious illness; those who are confined to their home, a hospital, or nursing facility; or those with serious underlying health conditions. One should consult the local pastor if questions arise about the obligation to attend Mass (canon 87).

Finally, safety protocols (such as wearing masks, social distancing, etc.) and liturgical directives (communion in the hand, communion under one species, etc.) in each New Jersey Diocese remain in place until modified or revoked by the respective Diocesan Bishop.

Also, on the weekend of June 5th/6th, open seating, offertory collections and all ministries will be reinstated.

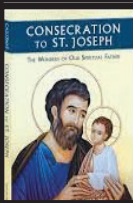
## RELIGIOUS EDUCATION

At the recent meeting between Betty Napoli, our Rel Ed Coordinator, with Fr. Harte, Deacon Joe, and Catechist Tom Salerno, it was agreed that we would offer all our Rel Ed families an additional window of time to finish their current year's religion texts, complete the exercises and update their reporting of progress by logging into Flip Grid. We will **NOT** be offering a Summer Program this year.

The date of Monday, August 16, 2021 has been established as the **FINAL DAY** for all students in Grades 1-7 to have completed their work for 2021.

After that date, registrations will be conducted for the Fall 2021-2022 Religious Education Program, as we hope to offer classes conducted face to face in the Annex classrooms. We are at work to enlist possible catechists for Fall. Families in our program will be receiving a letter/email from Betty Napoli detailing the "Wrap Up" for 2020-2021 school year.

For Grade 8 students preparing for Fall 2021 Confirmation, Catechist Tom Salerno requires you to deliver to him, in an envelope with your name written on the outside, your text (with assignments completed and filled in), your typed Saint Report, your typed Work of Mercy and Charity paper. Please drop off in the Hall, especially on Monday afternoons and evening or in the Church Lobby, where a box will be located.

**PLEASE TAKE NOTICE THAT** on October 1, 2020, The Diocese of Camden, New Jersey, (the “Diocese”) filed for protection under Chapter 11 of Title 11 of the US Code.

The Bankruptcy Court has established **June 30, 2021 at 11:59 p.m.** (prevailing Eastern time) as the deadline to file proofs of claim against the Diocese (the “Bar Date”). **If you have a claim against the Diocese including, without limitation, a claim related to sexual abuse committed by any person connected with the Diocese, you must file a claim on or before the Bar Date with Prime Clerk, the appointed Claims Agent.**

## COVID-19 Funeral Assistance

In March 2021, The Federal Emergency Management Agency (FEMA) announced a new program to provide financial assistance to families for certain COVID-19-related funeral expenses incurred due to a COVID-19-related death. FEMA began accepting applications for Funeral Assistance on April 12, 2021 through a dedicated call center. The telephone number for the FEMA Funeral Assistance Program is 844-684-6333 | TTY: 800-462-7585. Hours of operation are Monday through Friday 9 a.m. to 9 p.m. eastern time.

To apply you must call FEMA, there is no online application. The person applying must be the individual who incurred the funeral expense for the deceased. Please understand that FEMA will NOT speak to any businesses like funeral homes or cemeteries. No online applications will be accepted.

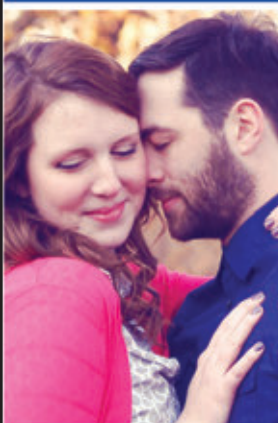
