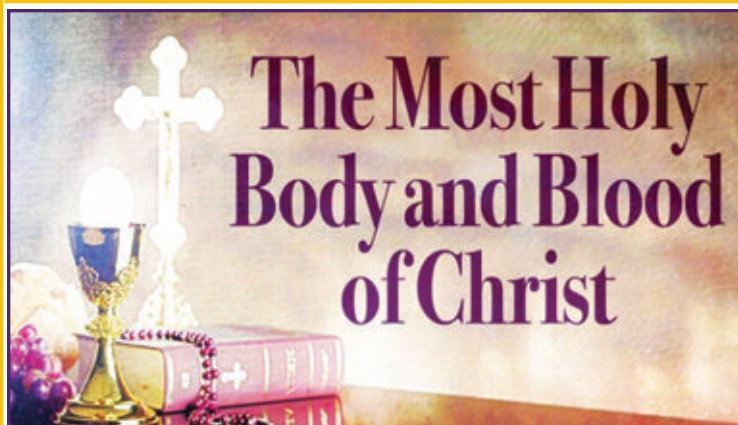

## **THE MOST HOLY BODY & BLOOD OF CHRIST (Corpus Christi)**

### **GLORIA**

### **FIRST READING:     **A reading from the Book of Exodus****

When Moses came to the people and related all the words and ordinances of the LORD, they all answered with one voice, "We will do everything that the LORD has told us." ## THE MOST HOLY BODY & BLOOD OF CHRIST (Corpus Christi)

### GOSPEL:

On the first day of the Feast of Unleavened Bread, when they sacrificed the Passover lamb, Jesus' disciples said to him, "Where do you want us to go and prepare for you to eat the Passover?" He sent two of his disciples and said to them, "Go into the city and a man will meet you, carrying a jar of water. Follow him. Wherever he enters, say to the master of the house, 'The Teacher says, "Where is my guest room where I may eat the Passover with my disciples?"'" Then he will show you a large upper room furnished and ready. Make the preparations for us there." The disciples then went off, entered the city, and found it just as he had told them; and they prepared the Passover. While they were eating, he took bread, said the blessing, broke it, gave it to them, and said, "Take it; this is my body." Then he took a cup, gave thanks, and gave it to them, and they all drank from it. He said to them, "This is my blood of the covenant, which will be shed for many. Amen, I say to you, I shall not drink again the fruit of the vine until the day when I drink it new in the kingdom of God." Then, after singing a hymn, they went out to the Mount of Olives.

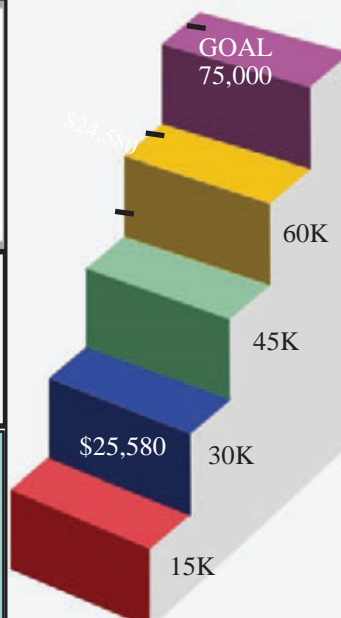

**STATEMENT OF THE NEW JERSEY BISHOPS**  
*Reinstating the General Obligation to Attend Mass*

At this time, due to the observance of public safety protocols and the increase in the availability of vaccines, we have begun a return to some sense of normalcy in various sectors of our society.

**Therefore, this weekend open seating, offertory collections and all ministries will be reinstated.**

The Catholic Bishops of New Jersey, are lifting the dispensation of the Sunday and Holy Days Mass Obligation this weekend of The Solemnity of the Most Holy Body and Blood of Christ. We welcome the Christian faithful to return to the regular participation in the Sunday Eucharist, the source and summit of our Catholic faith (cf. Code of Canon Law canon 1247 and Catechism of the Catholic Church, n. 2180).

This obligation does not apply to those who are ill; those who have reason to believe that they were recently exposed to the coronavirus or another serious or contagious illness; those who are confined to their home, a hospital, or nursing facility; or those with serious underlying health conditions. One should consult the local pastor if questions arise about the obligation to attend Mass (canon 87).

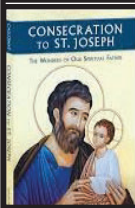
